Santa Cruz County.



# Update on the "No Place Like Home" Petition



A big thank you to everyone who invested in real change on the issue of homelessness by participating in our petition.

In four weeks we were able to gather 318 signatures, a significant amount compared to other petitions on this issue.

The legislation package re-purposes bond money from Proposition 63, the Mental Health Services Act, and creatively leverages billions of additional dollars from other local, state, and federal agencies to achieve goals on housing, income support, and outreach.

### In The News: South County Shelter



Our 2015 Santa Cruz County report "All In: Toward a Home for Every County Resident" identified a daytime drop-in center as the No. 1 need in South County.

Now the Salvation Army has launched a campaign to raise \$5 million for a new, three-story shelter to provide services to those in South County experiencing homelessness. These plans include a daytime drop-in center, complete with lockers, laundry and showers, plus internet-capable classrooms, counseling space, community rooms and offices.

The Salvation Army has successful partnerships with Teen Challenge Monterey Bay and Pajaro Rescue Mission, which have stepped in to run shelter services.


